

Memorandum of Understanding for International Cooperation in the Water Industry

Gyeonggi Province Water Resources Headquarters and Gyeonggi Environmental Energy Agency, Republic of Korea, and the Soc Trang Department of Agriculture and Environment, Socialist Republic of Vietnam (hereinafter referred to as the "Parties"), enter into this Memorandum of Understanding (MOU) to promote mutual development and cooperation in the water industry sector as follows:

Article 1 (Purpose)

The purpose of this MOU is to actively utilize the capabilities and resources of the Parties and foster cooperation for mutual development while making joint efforts to address pressing issues in the water resources sector.

Article 2 (Areas of Cooperation)

The Parties shall cooperate in the following areas:

1. Implementation of demonstration projects by Gyeonggi-based water companies in Soc Trang Province, Vietnam
2. Exchange of information and technology related to water industry and carbon neutrality
3. Support for business matching between water and renewable energy companies in both regions
4. Exchange of personnel and operation of educational programs related to the water and energy industries
5. Other areas deemed necessary for mutual cooperation

Article 3 (Roles of the Institutions)

1. Gyeonggi Province Water Resources Headquarters,
 - Selection and support of Gyeonggi-based water companies participating in demonstration projects
 - Development of cooperative projects in the fields of the water industry and carbon-neutral technologies
2. Soc Trang Department of Agriculture and Environment
 - Provision of local infrastructure and administrative support for demonstration project implementation
 - Supply of information on the local water industry and carbon-neutral technologies
 - Support for the local application and expansion of demonstration project outcomes

3. Gyeonggi Environmental Energy Agency

- Management of companies implementing demonstration projects and verification of local performance
- Provision of technical consulting necessary for demonstration project execution
- Other matters related to mutual cooperation for the implementation of demonstration projects

Article 4 (Confidentiality)

The Parties shall strictly protect confidential information obtained during the cooperation under this MOU and shall not disclose it to any fourth party without prior written consent from the other Parties.

Article 5 (Term of the Agreement)

This MOU shall be valid for three (3) years from the date of signing and may be extended upon mutual agreement between the Parties.

Article 6 (Amendments and Termination)

Any amendments or termination of this MOU shall be determined by mutual agreement in writing between the Parties.

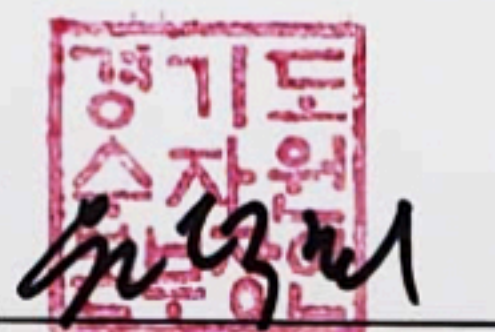
Article 7 (Miscellaneous)
